No.21/25/79-DP(Pt.III): In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Manipur is pleased to make the following rules further to amend the Manipur Secretariat Subordinate Service Rules, 1982, namely: -

1. Short Title and Commencement:

- (a) These Rules may be called the Manipur Secretariat Subordinate Services (1st Amendment) Rules, 2024.
- (b) These Rules shall come into force with effect from the date of publication in the official Gazette of Manipur.
- 2. The existing SCHEDULE-II(B) of the Manipur Secretariat Subordinate Services Rules, 1982 shall be substituted by the followings, namely:

- 3. Sl. No.3 of the existing Schedule -II (C) of the Manipur Secretariat Subordinate Services Rules, 1982 shall be substituted by the followings, namely:
 - i) Class X pass/Matriculate/HSLC/Equivalent from a recognized Board/Institution.
 - ii) Driving experience for 3 years possessing requisite driving license.
 - iii) Driving test to be conducted by Competent Authority.
 - iv) Select list shall be prepared on the basis of the mark score in the Driving/Trade Test and mark obtained in Class X Board examination.
 - v) Scheme of the written examination will be as follows:

4. The existing Rule 7(8) Driver of the Manipur Secretariat Subordinate Services Rules, 1982 shall be substituted by the followings, namely:

Rule 7(8) Driver:

Appointment to the post of Driver shall be made by "Promotion" failing which by "Direct Recruitment"

Recruitment shall be from the employees/candidates having passed HSLC Examination with valid license of driving of Light or Heavy Vehicles and at least 5 (five) years regular service in the grade (in case of promotion) or having 3 years driving experiences (in case of direct recruitment).
